#### **Commodity Insight**

#### **Crude Oil:**

➤ Global benchmark Brent crude futures corrected 17 per cent in the three months leading to September 2024, dragged down by the anticipated supply hike by the Organisation of Petroleum Exporting Countries and its allies (OPEC+) and weak demand from China. This brought prices down from the April 2024 peak of \$91.2 per barrel. On Monday, Brent rose above \$80 per barrel for the first time since August after more than a three per cent daily gain.

Globally, gold futures saw a 0.32% decrease, due to Weak global cues. Technically, the domestic yellow metal MCX (Dec 2024 Contract) gold witnessed selling pressure and closed with formation of bearish kind of candle on daily chart suggesting consolidation may continue and it can move towards 75350/75950/76120-800/77000 levels on the higher side. However, On the downside, the support for the MCX Gold is seen at 74450/73950/73500 levels. Technically the short-term trend on GOLD is likely to remain consolidation zone and traders are advised to trade with strict stoploss as volatility may remain high due to ongoing geopolitical tensions in middle east.
