Market View from the Technical Research Desk

Nifty



The benchmark Nifty had a very strong session yesterday. It opened with a big gap of +540 points, led by positive global sentiment and relentless DII support. However, it closed slightly below the opening high with a 500-point uptick. 48 stocks in the Nifty 50 Index ended the day positive, and only 2 stocks declined. IndusInd Bank, Shriram Finance, and Tata Motors were the top gainers, while ITC and Hindustan Unilever were the only losers with a minuscule decline. On the technical front, Nifty has shown good strength in the last couple of trading sessions. It has reclaimed levels above the key short-term and long-term exponential moving averages, however, it still needs to take down the 200-day exponential moving average resistance. On the daily chart, the Supertrend has turned positive, indicating a shift in the daily trend. However, it still needs to prove itself on other indicators. On the intraday chart, Nifty has been accelerating its momentum, clearly evident by steepening trendlines. Overall, Nifty is moving with strong momentum, absorbing supply and taking down key resistance levels with ease. Buying the dip will be a prudent strategy. Resistance is now placed at 23,500 and support is placed at 23,200/23,100. One can buy Nifty near its support above 23,200 for a target of 23,400/23,500. Any close below 23,050 will warrant a review of the current view.

Bank Nifty



Bank Nifty is in a very strong uptrend. Taking cues from global markets and domestic sentiment, it started yesterday's session with a big gap of +1,297 points. Although it experienced an intraday dip, it swiftly recovered and ended the session with a strong 1,377-point gain. All the index constituents ended the day in the green. IndusInd Bank, Axis Bank, AU Bank, and IDFC First Bank were the top gainers. Bulls completely dominated yesterday's session. On the technical front, Bank Nifty is showing strong momentum, trading above all the shortterm and long-term moving averages with a positive Supertrend. On the daily chart, a higher high and higher low pattern is in place, further validating the uptrend. It has successfully taken out the resistance at 51,900/52,000, which will now act as support. Overall, Bank Nifty remains bullish, and traders should adopt a "buy on dips" strategy. Support is now placed at 52,100/52,000, and resistance is seen at 52,700/52,800. One can consider buying Bank Nifty above the support levels of 52,100 for a target of 52,500/52,600/52800.
