#### **Weekly Technical View**

The broader index NIFTY 50 posted its second consecutive weekly loss weighed down by muted corporate earnings, persistent foreign fund outflows and losses in index heavyweight stocks. From a technical perspective, the NIFTY 50 index showed signs of indecision with a tug-of-war between buyers and sellers, resulting in the formation of a doji candle on the daily chart. Presently, the index is consolidating around its key demand zone within 23350-23500 levels and a failure to hold above this level could see it slide further towards 23100/22920 levels in the near term. On the upside, NIFTY 50 is expected to encounter resistance at 23680/23900 levels. A break above 23900 level could open the path for a move towards 24150/24380 levels. Keep an eye on global markets, ongoing geopolitical tensions, FII outflows and Crude oil price movements which will weigh on domestic market sentiments.
