Weekly Technical View



The frontline equity index NIFTY 50 extended its weak sentiment for the second consecutive week weighed down by concerns over subdued corporate earnings, persistent foreign fund outflows and rising crude oil prices. From a technical perspective, NIFTY 50 displayed a tug-of-war behavior between buyers and sellers and formed a doji candlestick pattern on the weekly chart. The index is currently consolidating within a bearish flag chart pattern in the 23050–23400 range on the daily chart. A breakdown below the bearish flag pattern could signal a trend continuation, dragging the index toward 22950/22800 levels. Conversely, resistance is observed at 23300/23450 levels, and a break above 23450 could push it toward 23560/23700 levels. Market participants should monitor Q3FY25 earnings, crude oil price movements and ongoing geopolitical tensions as these factors could influence domestic market trends.
