
Market Overview

Frontline indices Sensex and Nifty 50 ended in green on Tuesday, snapping their seven days losing streak amid mixed global cues and sustained buying from domestic institutional investors. The heavyweight index NSE Nifty 50 climbed 64.70 points or 0.28 percent to settle at 23,518.50 while the BSE Sensex surged 239.38 points to close at 77,578.38 with 17 constituents among the 30share index ending in green. Media and Realty stocks outperformed the sectoral indices while Metal stocks witnessed selling pressure in Monday's trading session. Among individual stocks, Mahindra & Mahindra and Tech Mahindra were the top performers, rising 3.58% and 2.34%, respectively. In contrast, SBI Life Insurance Company Ltd was the biggest laggard, falling 2.54%. The overall market remained positive with 2410 stocks advancing and 1559 stocks declining. On the institutional participation front, Foreign Institutional Investors (FIIs) extended their weak sentiment by divesting shares worth Rs 3,411.73 crore while Domestic Institutional Investors (DIIs) displayed confidence in the market by purchasing shares worth Rs 2,783.89 crore.

NIFTY vs India VIX





Business News

The company **Garden Reach Shipbuilders & Engineers** has secured a Rs 226.2 crore contract with the Transport Department of the Government of West Bengal for the delivery of 13 hybrid ferries. These ferries will operate on the River Hooghly under the West Bengal Transport Infrastructure Development Corporation, aiming to enhance the region's transport infrastructure and promote eco-friendly travel solutions.

The real estate developer **Godrej Properties** has acquired a 53-acre land parcel in Joka, Kolkata, with plans to develop a residential project. The proposed development is expected to offer 1.3 million square feet of saleable area, primarily focused on residential plots, and has an estimated revenue potential of Rs 500 crore.

The company **Kilburn Engineering** has entered into a share purchase agreement for the acquisition of Monga Strayfield, an engineering company that manufactures radio frequency dryers and heating solutions, for Rs 123 crore.

Economic Update (India & Global)

UK inflation jumps to 2.3 percent, underscoring BoE's stance for gradual rate cuts:

Consumer prices in the UK rose by an annual 2.3 percent in October, driven almost entirely by higher regulated domestic energy tariffs. This followed a 1.7 percent increase in September, marking the first time since 2021 that inflation fell below the Bank of England's (BoE) target. However, British inflation rebounded more sharply than expected last month, climbing back above the BoE's 2 percent target, with underlying price growth also accelerating. The rise pushed inflation to a six-month high and marked the largest month-on-month jump in the annual CPI rate since the inflation peak in October 2022. Services inflation, a key indicator of domestically generated price pressures closely monitored by the BoE, increased to 5.0 percent in October from 4.9 percent in September, aligning with BoE and market expectations. Nokia has secured a multi-year, multi-billion-dollar extension contract with the company **Bharti Airtel** to provide 4G and 5G equipment across major cities and states in India. Under this agreement, Nokia will deploy technology from its 5G AirScale portfolio, including base stations, baseband units, and advanced Massive MIMO radios, all supported by its energyefficient ReefShark System-on-Chip technology

The company **GNFC** has signed a Memorandum of Understanding (MOU) with INEOS Acetyls to explore the feasibility of constructing a world-scale 600,000tonne acetic acid plant at its site in Bharuch, Gujarat. INEOS Acetyls is a global leader in acetic acid production, while GNFC stands as India's sole current producer of acetic acid.







Intraday Stock Picks

The 50-stock index NIFTY pared early gains to settle 0.3 percent higher at 23,518.50 points on Tuesday, as escalating tensions between Russia and Ukraine weighed on investor sentiment. Technically, the NIFTY 50 failed to hold early gains and ended with a doji candlestick pattern featuring a long upper wick on the daily chart, indicating a lack of sustained upside momentum. Moreover, the index broke below its 200-day EMA, signalling a potential warning for investors of further downside risks. In terms of support and resistance, NIFTY 50 is expected to encounter resistance at 23560/23680 levels. Conversely, support for NIFTY can be seen at 23420/23350 levels. Keep an eye on global markets, ongoing geopolitical tensions, FII outflows and Crude oil price movements which will weigh on domestic market sentiments.

- In It

The BANKNIFTY index reflected indecisive behaviour among market participants and closed with a doji candle formation on the daily chart. From a technical standpoint, it sustained above the crucial 50500 level but lacked buying interest in the latter half of the session, indicating a consolidation phase. On the upside, resistance for BANKNIFTY is placed at 50850/51350 levels. In contrast, support for the banking index can be seen at 50300/50000/49700 levels. Traders are advised to use strict stop losses as volatility may remain high due to ongoing geopolitical tensions.
