
### **Market Overview**

Domestic equity benchmark indices Nifty 50 and Sensex scaled to fresh all-time highs on Wednesday fuelled by a rally in power and energy stocks. The Barometer BSE Sensex surged 255.83 points to surpass the 85000-mark for the first time, closing at 85,169.87 points while NSE Nifty 50 climbed 63.75 points to close at a new record of 26,004.15. Media and Realty stocks outperformed the sectoral indices while PSU Bank stocks witnessed selling pressure in yesterday's trading session. Among individual stocks, Power Grid Corporation of India and Axis Bank Ltd were the top performers, rising 3.91% and 2.30%, respectively. In contrast, LTI Mindtree was the biggest laggard, falling 3.81%. The fear gauge index, India VIX ended 4.85% lower indicating expectations of stable market conditions in the upcoming trading sessions. On the institutional participation front, Foreign Institutional Investors (FIIs) extended their profit booking journey at record highs by divesting shares worth Rs 973.94 crore while Domestic Institutional Investors (DIIs) displayed confidence in the domestic market by purchasing shares worth Rs 1,778.99 crore.

#### NIFTY vs India VIX





#### **Business News**

**PB Fintech**, the parent company of Policybazaar, is exploring plans to venture into the healthcare sector by establishing its own chain of hospitals. This move aims to unlock new value within the healthcare ecosystem, diversifying the company's portfolio beyond its current focus on insurance and financial services.

The company **Oil India** is about to start exploration activities in Nagaland and is engaged in discussions with the state and central government for the same. Additionally, the state-run company is hopeful of starting oil production from its block in Gabon in central Africa in the next financial year.

The company **IDFC Ltd** has received a green light from the National Company Law Tribunal (NCLT), Chennai for the merger of IDFC Financial Holding Company with IDFC and their merger into IDFC First Bank.

## **Economic Update (India & Global)**

# ADB retains India's economic growth forecast at 7 percent for FY24, 7.2 percent for FY25:

The Asian Development Bank (ADB) projects sustained strong growth for India's economy, forecasting a 7 percent increase in gross domestic product (GDP) for the financial year 2024 and 7.2 percent for FY2025. The projections were outlined in the bank's Asian Development Outlook report for September 2024. The report indicates that above-average monsoon across much of India is expected to stimulate strong agricultural growth, positively impacting the rural economy in FY2024. The ADB maintains a positive outlook for the industrial and services sectors, along with private investments and urban consumption for both FY2024 and FY2025. Due to the government's efforts toward fiscal consolidation, central government debt is projected to decline from 58.2 percent of GDP in FY2023 to 56.8 percent in FY2024. Consumer inflation is expected to rise to 4.7 percent in FY2024, driven by high food prices, despite the anticipated increase in agricultural output.

The company Coromandel International has acquired an additional 8.82 percent stake in Baobab Mining and Chemicals Corporation (BMCC), a Senegal-based rock phosphate mining company, bringing its total shareholding to 53.8 percent. It will invest \$3.84 million (Rs 32 crore) in BMCC, in addition to a loan infusion of \$6.5 million (Rs 54 crore) to fund expansion projects and meet working capital requirements.

The IT services company **Infosys** has announced a strategic collaboration with Polestar, the Swedish electric performance car brand. The partnership will focus on Polestar's in-car infotainment development, software and electronics engineering, user experience, and cloud-powered digital services.





## Market View from the Technical & Derivatives Research Desk



The Nifty 50 surged by 0.25 percent and tested fresh record high of 26,032 points due to strong buying momentum in large cap stocks. It closed the session above the 26,000 level for the first time. The index closed with bullish candle on daily chart suggesting upside momentum may continue. And it can move towards 26200/26500-800 levels, while on the lower side, the support will be at 25850/25590-460 levels. Technically the overall trend for NIFTY is likely to remain uptrend and any dips/profit booking would be a good buying opportunity for short term gains.



The BANKNIFTY traded in a tight range and ended with positive bias due to short covering. Technically the daily chart setup for BANKNIFTY is suggesting buying pressure may continue. On the higher side the immediate resistance will be at 54200/54600-55000 levels. However, on the downside the support will be at 53820/53650-250/53020 levels. Breakdown oof 53020 would invite further selling pressure and then we could see the index testing at 52750 levels. Traders are advised to apply buy on dips strategy for short term gains.
